Horan, Baue Discuss the Road to Acquisition

TORONTO – "There isn't a better landing spot than Park Lawn," commented John Horan the morning it was reported that Park Lawn Corporation had acquired both his firm, Horan & McConaty Funeral Services, and The Baue Funeral Home Co. "These are people who truly get it. My co-workers and I have observed humility, integrity and passion for this work and support for the people who carry it out."

Owner Lisa Baue said she chose Park Lawn after much due diligence to find a company that aligns with her company's mission and values. "There are many choices out there, but ultimately what was important to me and my son, John Baue Devaney, was the company culture Park Lawn believes in and lives every day in their organization," she said.

Horan said the path toward the acquisition was blazed last fall when he spoke with Jim Price, senior vice president of industry relations with PLC, about his role in Park Lawn and his impressions of the company. "My business partner, Daren Forbes, and I spent the day with this group and were taken aback by their sincerity, curiosity and keen insights," Horan continued. "We never saw this coming. Our somewhat closed attitude toward a transition began to open to the possibility that there is a company that appreciates our culture and local control and comes toward this with a level of servant leadership we knew was the right fit."

Horan and Forbes assembled their staff prior to the announcement. "The entire executive team from Park Lawn attended and presented, along with myself and Daren," Horan continued. "In addition to Daren, my co-owners also echoed the fit that uniquely describes Park Lawn. Frankly, we left money on the table to be part of Park Lawn."

Horan & McConaty grew from about 500 calls annually back in 1986 to almost 4,000 spread among Horan & McConaty, Pipkin-Braswell (Mark Pipkin and Alvin Braswell were co-owners of this African-American-focused business), Latina Funerals and Cremations, the Cremation Society of Colorado, Shalom Funeral Service, Columbine Monuments and The Cremation Gardens.

The not-for-profit HeartLight Center to support grieving people will continue to be led by Jennifer McBride, who was also a partner in the company.

Forbes takes on a larger role as vice president of the Western Region for Park Lawn. "Daren is a passionate and gifted leader and ideally suited to take on more responsibility," said Horan. "Dan Frakes and Michael Wellensiek will assume day-to-day control of the Denver operations. I love this work and will continue to assist on funerals, marketing and development."

Added Horan: "I have been surrounded by a phenomenal team of talented and dedicated caregivers. I can't tell you how much it means to me to know that our team culture will continue to be honored and respected."

A PERFECT MATCH

Baue echoed Horan's observation that the Park Lawn leadership team aligned well with her company in the desire to keep a horizontal structure, grow leaders at all levels and provide the very best in care for client families and team members. "Their company values of respect for the customer, the individual and the profession were extremely important to us as well," said Baue.

As Baue and her son discussed the family business transition this last year and their desire for the

company to be well cared for in the future, Baue said that both she and Devaney believe that Park Lawn will continue to invest in both the company and the community in ways that will perpetuate it for generations to come.
